Meet Peggy Niemer: Enjoying the Flexibility of Impact100 Membership

Peggy Niemer is one Impact member who enjoys the flexibility of her Impact100 participation. Son Richie and his wife Meredith live nearby making it easy for Peggy and her husband, John, to help care for the girls as needed during the week. From her Wauwatosa home, Peggy reflected on the flexibility she has found in her Impact100 involvement, "When I joined Impact100, it was at the invitation of Mary Therese Breger. Peggy went on to serve three years on the Impact100 board as Co-Director of the grants process. An enduring gift from that time was the friendship she formed with her co-director, Tracy Gobis. Paired together, they did not know each other but became close while sharing responsibility for the key grant-making mission of Impact100. Fun fact: They both became first-time grandmothers while working together.

Having finished her board service, Peggy chose to scale back on her Impact100 involvement for a few years, enjoying attending events and casting her vote. "I like that there is room for any and all participation levels" she notes. This year, she's begun learning about our member management platform from Systems Director, Nancy Kuhlmann, another friend she met through Impact100. Peggy also

enjoyed attending the recent Beyond the Headlines event.

An attorney specializing in corporate law, Peggy practiced in a large Milwaukee firm, GE and then began a long career in an executive position with Children's Hospital. She was active in the community. Despite that, she recalls being surprised by the number of nonprofits she first learned of through her Impact100 involvement. Likewise, Peggy recounts, "Through my grant director role, I met so many women who I'd never crossed paths with in my corporate career." Peggy points out there is one Impact100 member she already shared a connection with—son Richie's mother-in-law, Susan McNally. Grant Updates:

Decisions, Decisions...

The five committees of Impact100 volunteer grant reviewers have been thoroughly engaged the past two weeks in site visits to 13 different nonprofits throughout the area. Each committee typically visits 2-3 organizations chosen after a thorough application and review process.

Always a highlight of the grant cycle, site visits provide grant volunteers an opportunity to meet key staff members of prospective finalist organizations, tour facilities, and ask questions, as they see in person what they've read about in the grant application for each organization. On any given day, that might mean tromping in the rain to view the site of an environmental project or neighborhood art installation, then switching gears to tour a warehouse or observe a program.

Evaluation forms from the site visits provide the starting point for each committee's final meeting at which volunteers discuss what they've learned and weigh the merits of each proposed project or program. Then comes the hard part: Choosing the finalist organization their committee will advance for a full membership vote. Rarely is that an easy

Teens Grow Greens-And SO Much More!

Impact 100 Greater Milwaukee's 2021 Grant Recipient Teens Grow Greens will open Weber's Greenhouse for their retail sales on May 1, 2022 through July 1st. Located at <u>4215 N. Green</u> <u>Bay Avenue</u> in Milwaukee (just a half mile north of W. Capitol Drive and I-43), they will feature high quality annual flowers, perennials, herb varietals and organically grown vegetable starter plants, and hanging baskets. Weber's will reopen September 10 for their fall sale featuring pumpkins, mums, and other fall flowers plus decor.

Your dollars spent on purchases there will have the multiplier effect of supporting the TGG mission of "growing more than plants" by developing the workforce of tomorrow. The paid apprenticeships at Weber's provide teens with transformative experiences that cultivate a sense of belonging and connections to leadership opportunities. TGG Executive Director, Charlie Uihlein, provides an update on their project:

Impact100's \$100K grant supports the building of a new 2100 sq. ft. Teaching Greenhouse as a permanent home for and expansion of the youth experiential learning programs in STEM and agriculture. This provides a year-round opportunity for TGG interns and apprentices to hone their skills in growing, cooking, selling and distributing healthy foods, and teaching what they've learned. Groundbreaking for both the Teaching and Growing Greenhouses is set for spring 2023. Phase 1 of construction includes the designated \$100K grant from Impact 100.

We have reached our goal for Phase 1 with pledges. Impact 100 was the catalyst that
